#### **ORDER**

(Requiring Status Report on Outstanding Mandatory Disclosures)

The Licensing Board held an evidentiary hearing on August 19, 20 and 21, 2014, at the Hotel Alex Johnson in Rapid City, SD concerning seven contentions raised by the Oglala Sioux Tribe and the Consolidated Intervenors. On September 8, 2014 the Board issued a post hearing order which, inter alia, established a post-hearing procedural schedule and ordered mandatory disclosure of well data logs, correspondence with BLM, and a take permit application filed with the U.S. Fish and Wildlife Service.<sup>1</sup>

The parties were further directed to notify the Board when the disclosures were completed so that the Staff and Intervenors could decide whether or not to file supplemental testimony and exhibits on the issues heard by the Board at the evidentiary hearing.<sup>2</sup> The record

in this proceeding has been held open pending receipt by the Board of the notification of when disclosure was completed and motions, if any, to file additional evidence.

On September 11, 2014 Powertech USA, Inc. (Powertech) filed a joint motion to amend the Protective Order<sup>3</sup> in this case. The Board granted this motion on September 12, 2014.<sup>4</sup> The Joint Motion represented that Powertech planned to effectuate disclosure of all data and documents covered by the Protective Order, as well as all other non-confidential documents identified in the Licensing Board's September 8, 2014 Order beginning Friday, September 12, 2014.<sup>5</sup> Powertech stated, "CD copies of digitized data will be sent via overnight mail on that same day and electronic copies of other identified documents will be sent via electronic mail."<sup>6</sup> In the NRC Staff's September 15, 2014 Hearing File Update, the Staff listed three documents "Powertech recently disclosed to all parties: a January 2014 take permit application, a BLM letter regarding Powertech's proposed Plan of Operations, and a draft avian management plan."<sup>7</sup>

From this information the Board is currently under the impression that the avian take application, BLM letter, and draft avian management plan have been disclosed, but is unaware (1) what date this disclosure occurred, and (2) whether the well data has been disclosed. As a result, the Board is unable to determine whether the 30 day filing dead-line for any potential motions to admit additional testimony/exhibits has expired.
