- 1. My name is Elizabeth A. Scheinost. I am a Licensing and Environmental Compliance Engineer at Powertech (USA) Inc. (Powertech).
- 2. I copied two disks received from Energy Fuels onto Powertech's network exactly as they were provided to Powertech by Energy Fuels.
- 3. Sandra L. Montague, a Land Manager at Powertech, copied the files from the network onto DVDs.
- 4. I checked each DVD prepared by Ms. Montague to confirm that all files provided by Energy Fuels were accounted for by comparing the number of files on each DVD with the number of files provided on the two disks from Energy Fuels and by also comparing the file sizes on each DVD with the file sizes on the two disks from Energy Fuels. By doing this, I was able to confirm that each DVD sent out to hearing participants on September 12, 2014, contained all electronic files provided by Energy Fuels.
- 5. DISK 1 from Energy Fuels contains 6,152 filenames plus 1 index file and DISK 2 contains 10,150 filenames within 87 ZIP files plus 1 application file. Of the combined approximately 16,000 filenames, there are 3,866 duplicate filenames on DISK 2 and 6,029 duplicate filenames between DISKS 1 and 2. I compared the information in representative duplicate filenames and found it to be the same. Combining all DISK 1 and DISK 2 filenames into one list and removing all duplicate filenames results in 6,407 unique filenames plus 1 index file and 1 application file.
- 6. Of the 6,407 unique filenames, 3,075 provide digitized borehole gamma and resistivity data by depth or in other words the data that constitute a geophysical borehole log. These all have the file extension *.001 and may be opened and viewed using commonly available programs such as Notepad. The balance of the 6,407 files provides multiple programming and support files associated with the 3,075 digitized borehole logs.
- 7. In summary, the information on the DVDs sent to all parties on September 12, 2014, is exactly the same information as received from Energy Fuels. There are a number of duplicate files and also multiple programming and support files in the DISK 1 and 2

folders on the DVD. Removing these from the file count makes it possible to determine the number of digitized borehole logs provided by Energy Fuels, which is 3,075.
