Dear Administrative Judges:

On September 8, 2014, the Board ordered Powertech to disclose well log data it recently purchased from Energy Fuels.¹ The Board acknowledged that the well log data is proprietary information, however, and it invited the parties to modify the existing Protective Order in this hearing to address the well log data.² Several of the parties' representatives thereafter executed non-disclosure agreements, or modified existing non-disclosure agreements, thereby affirming that they would abide by the terms of the Board's protective order.

As allowed under the Board's September 8, 2014 order, today the Staff is submitting supplemental testimony and exhibits addressing the well log data and Powertech's other recent disclosures.³ Five of the Staff's exhibits reproduce Powertech's well log data in some form and, accordingly, contain information that is subject to the Board's Protective Order. To ensure these exhibits reach only those hearing participants who have executed non-disclosure agreements, the Staff is filing these exhibits through the non-public portion of the NRC's Electronic Information Exchange (EIE) (or by e-mail, for those exempted from EIE filing) and serving only those legal representatives who have signed a non-disclosure agreement.

The Staff is also submitting an affidavit certifying that the five listed exhibits reproduce information from Powertech's recently disclosed well log data and, therefore, contain proprietary information. The Staff is attaching the affidavit to this notice.

- I hereby certify that Exhibits NRC-166, NRC-168, NRC-169, NRC-172, and NRC-173 contain proprietary information that is exempt from disclosure. Specifically, these exhibits reproduce certain well log data that Powertech purchased from Energy Fuels Nuclear.
- 3. Exhibit NRC-166 contains a plate from Powertech's revised Technical Report (Plate 2.6-4). However, the drill hole surface elevations for the top of the Fuson Shale, which the NRC Staff added to the plate, are based on digital and paper logs that Powertech purchased from Energy Fuels. Therefore, Exhibit NRC-166 contains proprietary information.
- 4. Exhibits NRC-168, NRC-169, and NRC-172 are fence diagrams that the NRC Staff constructed from digital drill hole logs that Powertech purchased from Energy Fuels.
 Therefore, these exhibits also contain proprietary information.
