Ron,

This confirms our telephone discussion today, September 26, 2011, regarding formatting concerns for the revised TR. As I stated, Powertech (USA) Inc. proposes to revise and produce a complete TR with all appendices. The details of the formatting proposal are shown below:

#### Complete Document

- Complete document, will include full body of TR and all appendices
- Changes will be clearly indicated on revised pages, including where the change occurs on the page; vertical bars in the margins will be used to indicate the location of a change
- The Supplemental Report and associated appendices will be incorporated, so there will be only one final document

#### Focused Changes

- Changes will be made primarily to incorporate RAI responses (and subsequent open issues)
- Changes will include updates in facility design and permitting, e.g., copy of Class V UIC application
- Obsolete information will be omitted

#### Change Index

- A clear and comprehensive change index will be provided describing all changes
- The change index will include references for each RAI

#### Restoration Action Plan

- Will include all information relevant to closure activities in a stand-alone appendix, one convenient location
- Will include information relevant to groundwater restoration, decommissioning, reclamation, and financial assurance

#### ADAMS-Compliant

All documents will be ADAMS-compliant Please review and provide comments or statement of concurrence with proposed approach.
