Dear Mr. Blubaugh,

Thank you for the response.

As you know, NRC staff has begun the process to review Powertech's RAI responses. Those responses, in addition to your previous relevant submittals, constitute the current set of application materials that staff is evaluating for the Dewey-Burdock Project. If there is new material presented at this meeting that Powertech wants to incorporate into the application, staff will have to reevaluate our review schedule as it will require additional staff review time.

NRC staff has consistently communicated to Powertech that review schedules are determined by, among other things, the completeness of the application materials and the amount of new information submitted once a review has started. This was specifically stated in the April 7-8, 2011 public meeting, and recorded in the meeting summary (ML111030368), and transmitted in the May 6, 2011 letter to you from Keith McConnell (ML110470245).

Staff will evaluate the material presented at the December 7 public meeting and revise our review schedule as necessary.
